Question 3: Did you attend the virtual town hall, conference call held on Thursday, March 16, 2023?


Question 4: If the community votes down the FYE2024 assessment, do you want the board to revert to the FYE2023 as community president, Paul Bradley, plans to do?







“Did you attend the virtual town hall, conference call held on Thursday, March 16, 2023?”





“If the community votes down the FYE2024 assessment, do you want the board to revert to the FYE2023 as community president, Paul Bradley, plans to do?”








Question 7 has 17 answers (Radio Buttons)


Question 8 has 16 answers (Radio Buttons)
